**UNIVERSITY OF CALIFORNIA, RIVERSIDE
TEMPORARY VENDOR PERMIT AND
INDEMNIFICATION/HOLD HARMLESS AGREEMENT**

Native American Student Association (NASA), Native American Student Programs (NASP)

1. In consideration for permission to have an Information Booth as part of the Pow-Wow sponsored by NASA & NASP and being held on the University of California, Riverside campus on May 26 - 27, 2017, Vendor shall defend, indemnify, and hold The Regents of the University of California, its officers, agents, and employees from, harmless from and against any and all liability, loss, expense (including reasonable attorneys' fees), or claims for injury or damages arising out of the permission herein granted but only in proportion to and to the extent such liability, loss, expense, attorneys' fees, or claims for injury or damages are caused by or result from the negligent or intentional acts or omissions of Vendor, its officers, agents, or employees.

It is expressly understood that, for the purposes of the permission granted herein, Vendor is an Independent Contractor and not an employee or agent of the University or of the student group named herein. It is further agreed and understood that Vendor is not covered under the University's Workers' Compensation self-insurance program or any other University insurance program. Any injury to Vendor arising out of, or resulting from, the permission granted herein is the responsibility of Vendor.

2. Property Left Unattended/ Overnight on University premises. There is no assumption of liability by the University of California, Riverside campus and The Regents of the University of California for property left unattended or overnight. Vendor fully understands and assumes the risk for any property left unattended or overnight and release the University of California, Riverside campus and The Regents of the University of California from liability for any damage or loss to vendor's property. These risk may include, but is not limited to, damage or loss of property due to theft, vandalism, or weather conditions. There may be other risks not known or reasonably foreseeable.
